POLITICAL STATEMENT

(Your Party founding political statement: this sets out broad principles and purpose. It is not a programme or a manifesto – policies will be decided through the party's democracy).

Your Party is a democratic, member-led socialist party that stands for peace, equality, social justice, and international solidarity.

Its goal is the transfer of wealth and power, now concentrated in the hands of the few, to the overwhelming majority in a democratic, socialist society.

Its task is to build a mass party for the many that represents and is rooted in the broadest possible social coalition with the working class at its heart.

Your Party's aim is not only to win elections with a popular programme for real change, but to shift the balance of power at every level of society: organising and campaigning in communities and workplaces, trade unions and social movements across the nations and regions.

Your Party is committed to equality across society and opposed to all forms of prejudice, discrimination and scapegoating, which are weaponised by the ruling elites to divide people and communities.

The party stands for freedom for the many - from poverty, war and oppression - and in defence of democratic rights and liberties.

It shares in the worldwide opposition to a global system of imperial domination, colonisation and exploitation, and supports movements for national liberation and self-determination.

Both at home and abroad, Your Party stands against the war economy, and the neoliberal capitalist order fuelling the climate crisis and grotesque levels of inequality - and in favour of public and community ownership of key economic sectors and services.

Billionaires and corporations are now in control of our country. Your Party aims at its democratic and socialist transformation: by redistributing that power and wealth to all.

政治声明

(Your Party の創設政治声明:広範な原則と目的を定めるものです。政策綱領やマニフェストではなく、政策は党の民主主義を通じて決定されます)。

Your Party は民主的で党員主導の社会主義政党であり、平和・平等・社会的正義・国際連帯を掲げる。

その目標は、現在少数の手に集中している富と権力を、民主的社会主義社会において圧倒的多数へ移転することである。

その任務は、労働者階級を中核とし、可能な限り広範な社会連合に根ざし、多数派を代表する大衆政党を構築することである。

党の目的は、真の変化をもたらす大衆的プログラムで選挙に勝利するだけでなく、 社会のあらゆるレベルで権力のバランスを転換することにある。地域社会や職場、 労働組合、そして国や地域を越えた社会運動において組織化と運動を展開する。

党は社会全体の平等を追求し、支配層が人々やコミュニティを分断するために武器化するあらゆる形態の偏見、差別、スケープゴート化に反対する。

党は、貧困・戦争・抑圧からの解放という「多数派のための自由」を掲げ、民主的権利と自由の擁護を主張する。

帝国主義的支配・植民地化・搾取の世界システムに対する国際的反対運動に連帯し、民族解放と自己決定を求める運動を支援する。

国内外を問わず、Your Party は戦争経済と、気候危機と異常な格差を助長する新自由主義的資本主義秩序に反対し、主要経済部門と公共サービスの公共・共同体所有を支持する。

今や億万長者や企業が我が国を支配している。Your Party はその民主的・社会主義的変革を目指す。すなわち、その権力と富をすべての人々に再分配する。

Constitution

This document should be read as a working political draft, serving as the basis for democratic deliberation by members. Everything below will be subject to rigorous debate and amendment, in a process which will in the coming weeks produce a more exhaustive founding Constitution, then to be approved by the entire membership. This document should, moreover, be read in conjunction with the Standing

Orders options paper, and the introduction to both papers available on the Your Party website.

5. Organised Sections

1. Party Name:

The founding name of Your Party shall be determined by the democratic choice

of members, to be made prior to the founding conference via an online vote.

2. Party Purpose:

The Party's purpose will be laid out in the accompanying political statement, as

amended and voted on by members around the founding conference.

- **3**. **Party Structures** holds seven different areas for the purposes of this constitution:
 - a)Conference
 - b)Central Executive Committee
 - c)Leadership
 - d)Constituency and Ward-level Parties
 - e)Nations and Regions
 - f)Staffing
 - g)Community Organising

a) Conference

The Party shall have an annual National Conference, which, in addition to hearing reports on the Party's activities, shall consider issues of both party policy, and party structures and organisation. National Conference shall be sovereign, and its decisions binding on the Party's representatives and

bodies. Arrangements for National Conference shall be laid down in the Party's standing orders.

The Conference shall have powers to amend the Party's Constitution, where 2/3

of delegates vote in favour of such an amendment, submitted in line with the

standing orders.

b) Central Executive Committee

Basic Draft Proposal:

The Party's Central Executive Committee (CEC) shall be responsible for running the party, overseeing its staffing, guiding its operations, driving its strategy within parameters set by the National Conference, and determining its tactics.

The CEC shall consist of 16 ordinary members, representationally balanced in terms of gender, elected by the whole membership, the Leader, and 4 public office holder representatives, 2 of whom shall be Members of Parliament, and 2 of whom shall be local or regional public office holders.

There shall be additional reserved seats for organised sections (no more than five) and devolved nation representatives (one for each of Scotland and Wales) when these structures have been properly established.

The CEC shall elect National Officers including Chair, Deputy Chair, Secretary, Treasurer, Political Officer, and Spokesperson, who shall alongside the Leader make up the Officers' Group.

Neither the Chair nor the Deputy Chair shall be Members of Parliament.

The Officers' Group shall oversee the day-to-day running of the Party between CEC meetings, with the most senior staff attending and reporting directly to it, as well as being answerable to the wider CEC.

All ordinary CEC members shall be elected bi-annually by the whole membership.

In the Party's first year, the CEC shall establish two working groups, open to all CEC members, one aimed at thoroughly establishing all the Party's structures, especially its regional structures, and the other at finalising all its core documents.

Regularity of meetings and the establishment of other groups, working groups, or subcommittees shall all be matters at the discretion of the CEC.

c) Leadership:

Basic Draft Proposal:

A Leader shall be democratically elected in keeping with the proposals laid out in the Year 1 Organisational Paper. The constitution shall be updated thereafter.

The Leader shall form part of the Party's Leadership Team, alongside the Chair and Deputy Chair of the CEC, and shall provide political and strategic leadership as the Party establishes itself.

In the Party's second year, the CEC shall commence a review into different options for the future leadership, with recommendations and a range of leadership structure options. To allow for continuity of leadership, this review will be put to a democratic vote of members under OMOV, in advance of elections to be held before the National Conference in late 2027, with changes then incorporated in the constitution.

d) Branches:

Basic Draft Proposal:

The Party shall have branches across England, Wales, and Scotland, linked to Westminster parliamentary constituencies, Senedd constituencies and Holyrood constituencies as appropriate.

Branches shall be established through the holding of inaugural all-member meetings, which must be attended by [% to be established] of Party members in the constituency to be quorate, and at which a minimum of 5 branch officers must be elected which must include Chair, Treasurer,

Secretary, and Organiser, in a process overseen by the CEC or its appointed representative.

Branches shall, when a particular threshold is met, be able to form wardspecific groups within constituencies, allowing more localised discussion and organisation.

Other officer positions could include representative (women, disabled, LGBT+, BAME) and liaison (trade unions, social movement) roles.

In the Party's first two years, provision shall be made for Provisional Associate Branches, enabling existing local and community independent groups, already registered with the Electoral Commission, to affiliate politically to the Party without immediately subsuming themselves to it.

Thereafter, the Party shall have a unitary structure.

The Party shall have an Overseas Branch for members who remain eligible to vote in UK elections.

All Branches shall undertake workplace engagement and Party organising activities in the community as well as regular canvassing, and shall be appropriately resourced to do so.

All Branches shall undertake the necessary work to run regular publicfacing, local community assemblies. These assemblies shall be democratic and contribute to community activity and party policy development.

e) Nations and Regions:

Basic Draft Proposal:

i) Nations

Political Branches may be established in Scotland (Alba) and Wales (Cymru) as in England, but the devolved national structures – including governance and leadership – shall be determined by Scottish and Welsh members at their own founding conferences, to be held in the Party's first year.

Members in Scotland and Cymru shall, attendantly, have the right to a reserved section of the Party's constitution, so as to respect their right to

self-determination. Consultation for both these sections of the constitution shall take place as part of the 12-month strategic plan.

ii) English regions

In recognition of the necessity of first establishing branches, regional governance structures shall not be set up immediately.

Rather, the Party's CEC shall institute a working group tasked with generating recommendations as to the shape of the Party's regional governance, with appropriate feed-in from all the English regions.

The CEC shall then report on this matter to National Conference and the wider membership, providing a range of options which can be voted on.

f) Staffing:

Basic Draft Proposal:

In keeping with the principles laid out in the Year 1 Organisational Paper, all of the Party's hiring procedures shall include fair employment standards and processes, with strong safeguards against conflicts of interest, and shall be run democratically by the CEC. Any interim arrangements apply only to the period December 2025 till March 2026.

The most senior party staff shall be answerable to the CEC Chair, Deputy Chair, and Officers.

Appointed staff shall refrain from factional or political activity internal to the Party.

g) Community Organising Units:

A key differentiator of our party shall be its codification and implementation of community organising as a core part of party activity. This shall serve as an anchor between the party and local communities, giving people on the ground the resources to campaign at an autonomous, local level.

Below are a set of key considerations for community organising units (COUs), along with a set of proposed options for each. These are not exhaustive, and

should be added to or evolved, merged, reconsidered at every stage of consultation.

Structure Options (choose one):

- COUs and their goals are defined and run by the local parties (at constituency level, or where deemed appropriate, ward level or combined constituency level), with dedicated officers elected at said level with a remit and duty to ensure community organising and action take place. Regional or national community organising units would exist to lend support and advice, as well as distribute resources according to criteria agreed with local parties.
- 2. COUs are defined and run at a regional/national level, with a central office identifying where COUs would be most effective, according to criteria agreed with local parties. Local parties would determine what sort of organising needs to take place in their area. Dedicated officers would be elected at a local level to ensure that COUs are operating at the local level.

Options for additional consideration (choose as appropriate):

- A potential additional option, for local level parties, would be for those parties to join up to or assist already existing community organising in their area, at their discretion, to avoid duplication of work.
- An option for additional resource distribution could be based on the level of activity in COUs, with spare resources distributed favourably to the most active local units or units that make a case for expansion of activities. This should not affect base resource distribution for COUs overall.

Key questions and considerations for members:

- What level of party organisation are COUs tied to (national/regional, constituency or ward level)?
- How should resources be allocated towards COUs, both to start with as party launches, as well as beyond?
- How should COUs, their campaigns, etc. tie into other aspects of the party's mission, structure and procedures?
- Which party officers at different levels are responsible for supporting COUs and ensuring they remain compliant?

4. Membership:

Basic Draft Proposal:

The Party is a membership organisation. Ordinary Members shall be the core of the Party, with membership granting them rights to make party policy, partake in governing structures, select candidates for their area, and shape the life of the Party at all levels.

Every member must pay a monthly or annual subscription fee, to be set by the Central Executive Committee.

Robust democratic debate among members shall be central. The Party shall, at the same time, always seek to remain united, disciplined, and outward-facing. Members must accordingly respect the confidentiality of internal Party matters.

Members consent to their data being processed under the Party's Privacy Policy, set according to General Data Protection Regulation.

Breaches of rules may result in suspension, expulsion, or public disassociation according to Accountability and Standards Procedures.

Publicly elected members of the party, as well as party officers, will be required to agree to and adhere to a Code of Ethics in Office.

Members affirm their adherence to the Purpose, Aims and Objectives of the Party.

Members must comply with the Party's Constitution, Membership Rules, Standing Orders, and Disciplinary Procedures.

Members must act in a respectful, comradely, and non-abusive manner in all Party contexts, including Party meetings and on social media.

Members indemnify the Party against any liabilities arising from their application or membership.

Members may not hold membership in any other national political party, except if specified by the CEC.

Members may not affiliate with or participate in organisations undermining Party values.

Members must be UK residents or have the right to vote in UK elections.

Members must be at least 16 years old.

5. Party Affiliates:

A comprehensive consultation exercise and work plan for prospective Party Affiliates will take place as part of the party's opening 12-month strategic plan.

Affiliates encompass organisations such as trades unions, tenants unions/associations, campaign groups, etc. This list is not exhaustive.

6. Organised Sections:

Development of a membership-led body of work for Organised Sections will take place as part of the party's opening 12-month strategic plan to determine the best way for these to be organised within the party.

Organised sections encompass social groups such as the LGBTQ+ community, the disabled community, minority ethnic communities, women, young people, etc. This list is not exhaustive.

Your Party 憲章(草案•作業用政治文書)

(原題:Constitution - Working Political Draft)

本書は、党員による民主的な熟議のための作業用政治草案として読まれるべきものである。以下に示すすべての内容は、今後の数週間の討議と修正を経て、より包括的な「創設憲章」として完成し、全党員の承認を得ることを目的とする。また、本書は「議事規則案(Standing Orders options paper)」およびその導入文と合わせて読まれるべきである。

1. 党名(Party Name)

党の正式名称は、創立大会の前にオンライン投票によって行われる**党員の民主的** 選択により決定される。

2.党の目的(Party Purpose)

党の目的は、創立大会前後に党員が修正・採決を行う**政治的声明(Political Statement)**に明記される。

3.党の構造(Party Structures)

本憲章における党の組織区分は以下の7領域から成る。

- a) 全国大会(Conference)
- b) 中央執行委員会(CEC)
- c) 指導部(Leadership)
- d) 選挙区•区レベル支部(Constituency/Ward Parties)
- e) 各国•地域(Nations and Regions)
- f) 職員(Staffing)
- g) コミュニティ組織(Community Organising)

a) 全国大会(Conference)

- 毎年開催され、党の活動報告を受け、党の政策・組織運営に関する事項を審議する。
- **全国大会は党の最高意思決定機関(sovereign)**であり、その決定は党の代表者および組織に拘束力を持つ。
- 大会の運営要領は党の議事規則(Standing Orders)に定める。
- 憲章の改正は大会において可能であり、代議員の3分の2以上の賛成で成立する。

b) 中央執行委員会(Central Executive Committee:CEC)

- 党の運営、職員の監督、活動方針の策定、戦略の指導、戦術の決定を担う。
- 構成:
 - ・ 党員全体の選挙によって選ばれる通常委員 16 名(性別バランスを考慮)
 - 党首(Leader)
 - 公職代表 4 名:うち 2 名は国会議員(MP)、2 名は地方または地域の 公職者
 - 必要に応じて、「組織的部門」代表(最大 5 席)およびスコットランド・ウェールズ代表各 1名を追加
- CEC は次の全国役員を選出する:

議長・副議長・書記・会計・政治担当官・報道官。これらと党首で**役員団(Officers' Group)**を構成。

議長および副議長は国会議員であってはならない。

- 役員団は、CEC 会合の合間に党の日常業務を監督し、主要職員が直接報告する。
- 通常委員の任期は 2 年ごと(bi-annual)、全党員投票によって改選。
- 初年度には2つの作業部会を設置:
 - 1) 組織全体(特に地域構造)の確立
 - 2) 基本文書の最終化
- 会合頻度や他の分科会設置は CEC の裁量とする。

c) 指導部(Leadership)

- 党首(Leader)は、**第1年組織計画書(Organisational Paper)**に従い、民主的に選出される。
- 党首は CEC 議長・副議長とともに「指導チーム(Leadership Team)」を構成し、政治的・戦略的指導を担う。

• 第2年には CEC が将来の指導体制を検討し、選択肢を提示。党員投票 (OMOV)にかけ、2027年全国大会前に選挙を実施。結果は憲章に反映される。

d) 支部(Branches)

- イングランド・ウェールズ・スコットランドにおいて、議会選挙区単位で設立。
- **創立総会**において、所定割合の党員出席で定足数を満たし、少なくとも次の 5 役職を選出:

議長・会計・書記・オーガナイザーほか。CEC が監督。

- 一定条件を満たせば区(ward)単位の小支部設置も可。
- 女性・障害者・LGBT+・少数民族代表、労組・社会運動連絡担当などを置くことができる。
- 初期2年間は、既存の地域政治団体(選挙管理委員会登録済み)との**暫定的連携支部(Provisional Associate Branches)を認める。
 その後は単一構造(unitary structure)**とする。
- 在外英国選挙有権者のための「海外支部(Overseas Branch)」を設置。
- 各支部は地域での労働現場やコミュニティ活動・定期的な対話集会 (community assemblies)を実施し、党政策形成に寄与する。

e) 各国•地域(Nations and Regions)

i) 各国(Nations)

- スコットランド(Alba)およびウェールズ(Cymru)における支部も設立可。
- それぞれのガバナンス・指導体制は当該国の党員による**独自の創立大会**で 決定。
- 両国は党憲章の一部に**独立条項(reserved section)**を持つ権利を有する。
- これらに関する協議は12か月戦略計画の一環として実施。

ii) イングランドの地域(English Regions)

- まず支部の確立を優先し、地域ガバナンスは直ちには設置しない。
- CEC が作業部会を設け、地域組織の形態案を検討し、全国大会に報告。
- 会員投票で採択する。

f) 職員(Staffing)

- 採用手続きは「第1年組織計画書」に基づき、公正雇用基準と利害衝突防止 を備える。
- 採用管理は CEC が民主的に実施。暫定措置は 2025 年 12 月~2026 年 3 月までに限定。
- 上級職員は CEC 議長・副議長・役員団に報告義務を持つ。
- 職員は党内派閥活動を行ってはならない。

g) コミュニティ組織部(Community Organising Units:COUs)

- 党の特徴として、**地域コミュニティ組織活動を制度化**し、地方レベルで自律的な運動を支える。
- 以下2案が提示され、党員討議に付す:

構造案(いずれか選択)

- 1. **地方党主導型**:選挙区または区レベルで COU を設け、専任役員を選出。地域 や全国 COU は支援・助言・資源配分を担う。
- 2. **地域/全国主導型:**中央事務局が COU 設置地域を決定、地元党組織と協 働。

追加検討事項

- 既存の地域運動との連携・支援を認め、重複を避ける。
- 活動水準に応じた資源配分(成果に基づく追加支援)も検討。

党員に問われる主要論点

- COU はどのレベル(全国/地域/選挙区/区)に属すべきか?
- COU への資源配分の方法は?
- COU の活動を党の使命・構造とどう結合させるか?
- 各レベルでどの役員が COU 支援・監督責任を負うか?

4. 党員資格 (Membership)

- 党は**党員制組織**である。党員は政策立案•候補者選定•組織運営への参加権 を持つ。
- 会費は CEC が定める月額または年額。
- 党内民主的討論を重視しつつ、団結・規律・対外的視野を保つ。
- 内部事項の守秘義務を尊重する。
- GDPR に基づく個人情報保護方針に同意。
- 規則違反は、停止・除名・公的関係解消の対象となる。
- 公職者・役員は倫理規範(Code of Ethics in Office)に従う。
- 党の目的・方針を遵守することを誓約。
- 憲章・会員規則・議事規則・懲戒手続を遵守。
- 全ての党活動で尊敬と連帯をもって振る舞う。
- 党は会員による行為に起因する責任を負わない(免責条項)。
- 他の全国政党との二重党籍は禁止(CEC が例外を定める場合を除く)。
- 党の価値を損なう団体への参加は禁止。
- 英国在住または英国選挙の投票権を持つ者。
- 加入年齢は16歳以上。

5. 党の提携団体(Party Affiliates)

- 発足後 12 か月の戦略計画の一環として、提携団体制度に関する**協議と行動** 計画を実施。
- 提携団体には労働組合、借家人組合、キャンペーングループなどを含む(例示的)。

6.組織的部門(Organised Sections)

- LGBTQ+・障害者・少数民族・女性・若者などの社会的グループによる部門活動を設計。
- 発足後12か月の戦略計画の一環として、最適な組織形態を党員主導で検討。

総括

この憲章草案は、

- 草の根民主主義(member-led democracy)
- 地域運動と政党の融合
- 多様性・分権的組織原理 を基本理念としており、従来の労働党型ヒエラルキーとは異なる「水平的・ 参加型」モデルを模索しています。

STANDING ORDERS

All key questions and options presented in this document are subject to debate, changes, additions, and rejections as the new party's constitution and founding documents are brought to party members and assemblies for consideration. None of the contents of this document should be taken as final or exhaustive, and should be read in conjunction with the Constitution options paper. For more information, see the introduction to the Constitution and Standing Orders, available on the Your Party website.

Standing Order Options Content:

- 1. Conferences
- 2. Local Party Meetings and Assemblies
- 3. Conduct of Party Elections
- 4. Policy Development

Conferences

The party needs rules and structure for its conferences. In order to ensure conferences throughout the party are easy for members to understand, and ensure they are as accessible as possible to all regardless of prior levels of engagement, these rules should apply to all party conferences as much as possible or practicable.

Questions to consider:

- Who attends party conferences? Is it elected delegates, or is it open to all members in good standing? Are attendees selected by random sortition?
- What voting system is used for conference decisions? Do just attendees/delegates vote, or do online systems exist to ensure all members can vote on matters at conference?
- In the context of bringing motions to conference, how do different people and parts of the party come together to composite similar policy motions?
- How are motions brought to conferences, and how do those bind the party? How do conferences ensure motions they consider are competent?
- How are speaking rights distributed at conferences? How long do speakers have on a motion, its rebuttal? Do speakers need a seconder?

Conference Options:

The Conference shall be organised by the CEC, delegating as necessary.

a) In-Person Attendees (choose one)

- 1. Attendees could be elected delegates per local party, organised sections and affiliates.
- 2. Any member in good standing could attend and would be selected randomly via sortition.

b) Hybrid Conference:

- 1. Should endeavours be made to ensure future conferences are hybrid events (with both online and in-person attendance)?
- Accept or Reject

c) Conference voting* (choose one):

- 1. Voting at conferences could be reserved for conference delegates from local parties, organised sections and affiliates.
- 2. Voting at conferences could be reserved for members selected to attend via sortition.
- 3. Voting at conferences could be open to all members in good standing regardless of whether they are attending conferences (in-person, or online, or not).

d) Voting Weightings* (choose one):

- 1. Voting at conferences is run on the basis of one member (voting attendee) one vote.
- 2. Voting at conferences is run on the basis of party-wide one member one vote.

Voting at conferences should take place on a delegated basis, with weightings attributed to local party size, as well as organised sections and affiliates.

*These sets of options need to be considered together, as choice on who gets to vote at conferences has an inevitable impact on how vote weightings are decided.

e) Voting thresholds (choose one):

- 1. Votes are conducted by a simple majority of voting attendees for all conference business.
- 2. Votes are conducted by a simple majority of voting attendees, however votes affecting the party's standing orders are conducted by ²/₃ majority of voting attendees.

Note that thresholds for amending the Constitution fall within the scope of the Constitution itself.

f) Motions to conferences (choose one):

- 1. Motions are brought to conferences by local parties, organised sections and affiliates.
- Motions are brought to conferences by proposition of any member in good standing, with a threshold of seconders to be met for consideration, that threshold varying per conference. If too many motions make the quota, the most popular motions per policy category will be selected.
- 3. Motions are brought to conference via an online voting system, with the most popular motions per policy category being selected.

g) Length of motions to conference (choose one):

1. Maximum of 400 words.

- 2. Maximum of 300 words.
- 3. Maximum of 250 words.

h) Motion Compositing (choose one):

To ensure that different motions on a same topic can be potentially put forward as a single motion to a given conference:

- 1. There could be a motions compositing committee, directly elected by members of the party.
- 2. There could be a motions compositing committee, elected through the relevant executive body.
- 3. There could be a motions compositing committee, composed of delegates and/or wider members bringing those motions to conference.

j) There will need to be a Conference Motion Policy Committee, which will ensure that policy motions do not fall short of basic expectation and oversee the submission of motions, including the timetable.

- 1. Those expectations could be that motions are:
 - 1. not contrary to the Constitution;
 - 2. not retrospective in their effect;
 - 3. not ambiguous;
 - 4. not vague;
 - 5. not trivial;
 - 6. not requiring no consequential action by the party;
 - not seeking to re-present a motion proposal which has been debated and defeated at conference or in a party referendum within the last 12 months, except where an exemption is made for urgent policy.
- · Accept or Reject
- 2. The Conference Motion Policy Committee could be comprised of:
 - 1. Directly elected members
 - 2. Members of the national executive

- 3. Local party officers
- Accept or Reject

k) Supporting and speaking to motions:

- 1. Anyone successfully submitting a motion to conference must be able to speak to the motion, and will have up to 3 minutes to do so.
- · Accept or Reject
 - 2. Anyone speaking in support of a motion (but not having submitted it) or against a motion will have 2 minutes to do so.
- · Accept or Reject
 - 3. Anyone speaking in support of a motion (but not having submitted it) or against a motion needs a seconder present.
- Accept or Reject

2. Local Party Meetings and Assemblies

In the interest of facilitating open, deliberative and action-oriented local branches, the new left party will adopt a two-pronged system for local parties, one based on meetings and organisation of full party members, the second based on open, publicly facing democratic assemblies.

Key Questions to Consider:

- How do rules ensure that local party members' meetings are at once as open, accessible and flexible as possible?
- Who sets the rules for the conduct of meetings? Could it be set by local branches autonomously? Or should a minimal, standard format be set for all local parties to follow?

 How do rules ensure they are accessible, engaging and lead to productive action for the wider public?

a) Local Party Meeting Options:

- Local party meetings must occur at least once per month.
- All party members must be invited to local party meetings, and must be invited at least 7 days before any such local party meeting occurs.
- Decision making at local meetings must be made democratically by members, where feasible by simple majority.
- A component of party meetings must be a focus on the running of a local assembly, wider community work and any other matters that serve to embed the local party into the community.

a. <u>i) Running Meetings (choose one):</u>

- 1. The agenda and running of local party meetings is left entirely to the members of the local party committee and the wider membership.
- The agenda and running of local party meetings is left mostly to the members of the local party committee and the wider membership, besides some common items required to be covered regularly across all local parties.

a. ii) Hybrid Local Party Meetings:

- 1. Should endeavours be made to ensure local party meetings are hybrid events (with both online and in-person attendance)?
- Accept or Reject

b) Local Assembly Meeting Options:

- Local party officers and members must be involved in the coordination and running of local assemblies.
- Local assemblies must serve their local communities.
- Any political decisions or work taken forward through local assemblies must reflect the overall democratic will of said assembly.
- Community members must be invited to local assemblies, and must be invited at least 14 days before any such local assembly meeting occurs.

b. i) Hybrid Local Assembly Meetings:

- 1. Should endeavours be made to ensure local assembly meetings are hybrid events (with both online and in-person attendance)?
- Accept or Reject

3. Conduct of Party Elections

Please note that the various positions of local party officers, as well as national and regional party officers, will be determined according to the decisions made around <u>Party Structures</u> in the constitution, particularly the <u>Central Executive Committee</u>, <u>Leadership</u>, <u>Branches</u> and <u>Nations and Regions</u> sections.

a. <u>Local Party Officers:</u>

- All local party members have the right to vote for their local party officers.
- Full notice of election must be sent to all local party members at least 28 days before the date of local party officer elections.
- Any local party member wishing to stand as a local party officer must be in good standing and must submit a nomination paper no later than 14 days before the date of local party officer elections.
- An all-candidate list must be provided to all local party members no later than 7 days before the date of local party officer elections.

a. i) Eligibility for candidacy:

- 1. Any member in good standing can run for any local party officer position.
- Accept or Reject

a.ii) Seconders (choose one):

- 1. Candidates for local party officers positions can self-nominate.
- 2. Candidates for local party officers require a certain number of seconders to their nomination.

a.iii) Voting System (choose one):

- First Past the Post (most votes wins, regardless majority achieved) explainer
- 2. Single Transferable Vote (ranked preference with transfers, majority wins) explainer
- 3. Open List Proportional Representation (*per-candidate approval, most approved wins*) <u>explainer</u>

a.iv) Length of Term (choose one):

- 1. 12 months
- 2. 24 months

a.v) Recall Votes:

- 1. If 40% of members in good standing within the local party sign a dedicated recall petition for an officer, then this will trigger a vote on that party officer's continuation in the role. Active recall petitions will be available on the party website for a period of 28 days.
- Accept or Reject

b) Regional/National Party Officers:

- All members will have the right to vote for their national and regional party officers, including for national and regional officers.
- Full notice of national and regional officer elections must be sent to all party members at least 6 weeks before the date of election.

- Any party member wishing to stand as a national or regional officer must be in good standing and must submit a nomination paper no later than 21 days before the date of national and regional officer elections
- An all-candidate list must be provided to all relevant party members for those elections no later than 10 days before the date of national and regional officer elections.

b.i) Eligibility for candidacy (choose one):

- Any member in good standing can run for any position in national or regional officer elections.
- 2. Any member in good standing can run for any position in national or regional officer elections, other than leadership (leader, deputy leader, spokesperson) positions, which only publicly elected party members can run for.

b.ii) Seconders:

- 1. Candidates for national or regional officers require a certain number of seconders to their nomination.
- · Accept or Reject.

b.iii) Voting System (choose one):

- First Past the Post (most votes wins, regardless majority achieved) explainer
- 2. Single Transferable Vote (ranked preference with transfers, majority wins) explainer
- 3. Open List Proportional Representation (*per-candidate approval, most approved wins*) *explainer*

b.iv) Length of Term for officers (choose one):

- 1. 24 months
- 2. 36 months
- 3. 48 months

b.v) Recall Votes:

- 1. If 40% of members in good standing within the relevant party unit sign a dedicated recall petition for an officer, then this will trigger a vote on that party officer's continuation in the role. Active recall petitions will be available on the party website for a period of 28 days.
- Accept or Reject

c) Candidates for Public Office:

- All Party candidates will be chosen democratically by all-member meetings of the relevant branch or ward.
- There must be a full candidates primary process, which includes democratic longlisting and shortlisting processes involving local members.
- These processes must be free from interference from party bodies other than the local party, except where disciplinary matters arise.
- Candidates may only be disbarred from standing in specific exceptional circumstances;
 - These circumstances include genuine due diligence concerns relating to matters of clear personal misconduct;
 - The local party branch will have a representative on any committee overseeing due diligence;
 - This provision shall not be misused for political purposes.
- The Party's CEC shall oversee candidate selections, but shall not unduly overrule branches or local members for political reasons.
- All members in good standing who pass the necessary nomination thresholds shall be able to stand for selection unimpeded.

c.i) Eligibility for candidacy:

Any member can put themselves forward to be a candidate, so long as
they are in good standing, and from the moment the party has had
membership open for 12 months, has been a member of the party for 12
months or more. This 12-month rule will not apply in instances where a
current public office holder joins the party from elsewhere. Elected
Parliamentarians will be disbarred from switching or choosing an
alternative constituency for reasons of convenience or personal interest.

Accept or Reject

c.ii) Seconders (choose one):

- 1. Candidates for public office positions can self-nominate.
- 2. Candidates for public office positions require a certain number of seconders to their nomination.

c.iii) Voting System (choose one):

- First Past the Post (most votes wins, regardless majority achieved) explainer
- 2. Single Transferable Vote (*ranked preference with transfers, majority wins*) <u>explainer</u>
- 3. Open List Proportional Representation (*per-candidate approval, most approved wins*) <u>explainer</u>

c.iv) Recall Votes:

- 1. If 40% of members in good standing within the relevant party unit sign a dedicated recall petition for a party public office holder, then this will trigger a vote on that office holder's continuation as an elected representative of the party. Active recall petitions will be available on the party website for a period of 28 days.
- Accept or Reject

c.v) Mandatory Reselections:

- Incumbent publicly elected party members shall be subject to cyclical primary contests, to be held by the local party before the relevant scheduled public election.
- Accept or Reject

4. Policy Development

As a political party, running for office at multiple levels of government across the country, the new left party will require a robust and accountable policy formation

process. It is an expected desire that the new party's policy agenda be formed by the grassroots, in an open and transparent fashion. We must note that it will also be expected by the wider voting public that party policy be relevant to their needs and is sufficiently competent to improve their livelihoods.

Please note that aspects of policy development will be affected by the decisions made in the party's constitution, specifically that around the role of local party assemblies in the **Branches** section of that document.

Key considerations:

- Who by and how does a local policy come to be constructed?
- How does policy development at the local level consistently link back to the demands of local communities, as well as party members?
- How could policy development be organised at the local level to ensure practical implementation in local government? How can the party on the national, and inter-local scale assist in developing policy, without interfering in it?
- How does a policy get approved at the end of a process development, and who by?
- Once policy development is complete and agreed on an issue, how can local parties ensure that they are consistently adapted to ongoing developments?
- How do local parties come together, both within their communities, and then with each other, to develop national policy?
- What is the role of national or regional party bodies in the development of national policy? Where do they fit in the pipeline from policy proposal, to building, to final approval and continued assessment?
- What accountability systems exist to ensure policy decided by conferences is then developed, and where possible, carried out?

a. <u>Local Policy:</u>

Local party units will be empowered to develop policy proposals for their local area. As a unitary party, the National Conference and CEC shall remain sovereign, and local parties may not commit to policies contradicting national policy.

a.i) Policy Dev Process Initiation (choose one):

- 1. Local policy to develop is discussed and voted on democratically at the local party assemblies (by one attendee one vote, simple majority).
- 2. Local policy to develop is voted by members, after deliberation at the local party assemblies (by one member one vote, simple majority).
- 3. Local policy to develop is debated and voted on by members (by one member one vote, simple majority).

a.ii) Policy Dev Process (choose as appropriate):

1. Local policy is developed by an agreed team of the local party/assembly, which could include:

Local party members and officers.

Participants of the local assembly.

Representatives from affiliates organisations or organised sections.

Party members who hold a local public office.

2. Additionally, it could include in a non-voting/non-deciding capacity, at the local party's discretion:

Expertise from local community organisations not affiliated to the party.

Members from other local parties to share ideas or solutions from other parts of the country.

a.iii) Local Policy Approval (choose one):

Once a policy team arrives at the conclusion of its policy-creation process,

- 1. Party members have the final say on whether to accept or reject the local policy proposal (by one member, one vote).
- 2. The local assembly will have the final say on whether to accept or reject the local policy proposal (by one attendee, one vote).

a.iv) Upon Rejection (choose one):

- 1. The body rejecting a piece of policy work may choose to have it sent back for further work, and a new vote after review and revision.
- 2. A rejected piece of policy work is discarded or returned for further work according to the mission statement or motions of a local party's members or assembly.
- 3. A rejected piece of policy work is discarded and must be re-initiated by the relevant body to be reconsidered after any revision.

a.v) Upon Acceptance:

- 1. A team of party members is designated, at the local party's discretion, to regularly review the competence and relevance of local party policy, in response to all relevant and affecting local and national developments.
- · Accept or Reject

b) National Policy:

- Local parties should be encouraged to discuss national policy formation for conference, with a view to forming consensus.
- Ultimately, conference is the primary determinant body for national policy
 between Conferences, the CEC remains the highest party body.

 National policy should at all times reflect the aims, values and objectives of the party.

b.i) Policy Dev Process Initiation (choose one):

- National policy to be sent to conference by a local party is discussed and voted on democratically at the local party assemblies (by one attendee one vote, simple majority).
- 2. National policy to be sent to conference by a local party is voted on by members, after deliberation at the local party assemblies (by one member one vote, simple majority).
- 3. National policy to be sent to conference by a local party is debated and voted on by members (by one member one vote, simple majority).
- 4. National policy to be sent to conferences is determined by wider online voting systems.

b.ii) Policy Dev Procedure (choose one):

Once a policy proposal is approved at a conference, national policy could be developed by a policy implementation group. This body could:

- 1. Could be directly elected by members.
- 2. Could be assigned from the relevant executive body.
- 3. Could be assigned by sortition of all interested party members.

b.iii) Policy Approval (choose one):

Once a policy implementation group has completed its work on a piece of national policy:

- 1. Approval could be decided on by a manifesto writing body, directly elected by members.
- 2. National policy approval could be decided on by a manifesto writing body, appointed by the elected CEC.
- 3. National policy could be approved through a final online vote of all members.

b.iv) Upon Rejection (choose one):

- 1. The body rejecting a piece of policy work may choose to have it sent back for further work, and a new vote after review and revision.
- 2. A rejected piece of policy work is discarded or returned for further work according to the mission statement or motions of the relevant party body.
- 3. A rejected piece of policy work is discarded and must be re-initiated by the relevant conference to be reconsidered after any revision.

STANDING ORDERS(議事規則案•草案)

4. Policy Development(政策策定)

全国各層の選挙に臨む政党として、新左派政党は堅牢で説明責任ある政策形成プロセスを要する。政策アジェンダは草の根によって公開・透明に形成されることが期待される。同時に、有権者からは政策が生活改善に資するだけの**妥当性 (competence)**を有することも期待される。

(注)政策策定の一部は、憲章の**支部(Branches)における地域アセンブリの役割**に関する決定の影響を受ける。

- 地域レベルの政策策定が、**地域社会の要求と党員の意思**に一貫して接続されるにはどうするか。

- 1. 開発すべき地域政策を**地域アセンブリ**で討議し、一出席者一票・単純多数で 決める。
- 2. 地域アセンブリでの熟議後、**党員投票(OMOV・単純多数)**で決める。
- 3. **党員**が **OMOV・単純多数**で討議・決定する。

a.ii) プロセス(必要に応じ選択)

- 1. 地域党/アセンブリで合意した**政策チーム**が策定する。構成例:
 - 地域党員•役員
 - 地域アセンブリ参加者
 - 提携団体・組織的部門の代表
 - 地方公職にある党員

1. Introduction and Vision - What are we working towards?

Your Party shall be a unitary mass party, deeply rooted in the socialist tradition and indivisible from the workers' movement. The Party recognises the scale of this challenge – given such an organisation of the left has never before been built in Britain, the decline of mass political forms in general, and the gradual decoupling of the working class from the left – but nevertheless believes its

undertaking to be essential. The Party believes its mass character to consist not only in membership scale or capacity to cohere and lead the left, but in a relentless focus on building a social majority behind its programme.

Such a majoritarian orientation is geared towards fostering the conditions of possibility for the radical transformation of British society in the interests of the overwhelming majority.

The Party has been built on the success of the Independents' Movement, itself underpinned by a new electoral coalition horrified in equal measure by the Labour Party's abandonment of working-class people and its complicity in genocide. The old parties are ignoring the voters, with Labour in particular relentlessly attacking its own support base, contributing to a backlash that has fuelled the rise of the far right.

Your Party will do things differently, organising in communities to build our power by growing the workers' movement and strengthening social movements, whilst also seeking to contest and win elections at local, regional and national level.

Democracy, inclusion and transparency will be at the heart of everything Your Party practices and advocates, with a focus on building up our collective force, not tearing each other down.

2. <u>Strategic Objectives (first year):</u>

We are on the path to having a unitary party organisation. Building will be our overarching objectives for our first year: our structures, our membership and our organisation This will include:

a. <u>Building memberships:</u> Organisational growth reaching all areas of the working class, including and especially areas abandoned by Labour and where

the far-right are now gaining ground.

- b. <u>Building structures</u>: We will work to implement the decisions taken at Conference 2025 and facilitate the building of our structures, including running internal elections. This requires a small team consisting of a General Secretary, with limited support staff, to deliver these democratic structures, support members to form branches, and facilitate the self-organisation of the nations and sections.
- c. <u>Building organisation</u>: Establish the Party in communities and workplaces. Community organisers and trade unionists must play a primary role in all that we aim to do and achieve, in keeping with organisational strategy as determined by the Leadership and CEC.

We must also face outwards, including seeking to contest democratically at the ballot box.

- d. <u>Political leadership</u>: Provide clear decisive political leadership, always firmly rooted in our core socialist and anti-imperialist principles, as we work to build a social majority for our programme.
- i.Alongside mass community and workplace organising, we will work to fulfil our legal and electoral responsibilities, including by maximising the number of candidates aligned to the party at the 2026 local elections, with arrangements for the nations of Scotland and Wales to be determined. The Party will be highly professional and will always function in a manner that allows for maximum membership participation.

This paper contains practical organisational proposals for Your Party, in keeping with the Political Statement, Constitution, and Standing Orders.

3. Election of Leader and Central Executive Committee (CEC)

Elections for the Party's Leader and Central Executive Committee (CEC) will commence in January 2026, the earliest practical start time following the founding conference. Voting will be run by a trusted, independent, third-party company. These elections will conclude no later than 31st March 2026, at which point the CEC will immediately take over management of the party with the new leadership team.

4. Leadership

- i. The Party's first Leader shall be elected by the whole membership (under a one-member-one-vote system) and shall serve for a term of no more than 21 months. Thereafter elections will be held in advance of our national conference, and the Leader shall serve for the period determined by the final constitution.
- ii. The Leader shall form part of the Party's Leadership Team, alongside the Chair and Deputy Chair of the CEC, and shall provide political and strategic leadership as the Party establishes itself, overseeing the work of the General Secretary.
- iii. In the Party's second year, the CEC shall commence a review into different options for the future leadership, with recommendations and a range of leadership structure options. To allow for continuity of leadership, this review will be put to a democratic vote of members under OMOV, in advance of elections to be held before the National Conference in late 2027, with changes then incorporated in the constitution.

iv. In the short period between the founding conference and the election of the first CEC, the party will continue to be stewarded on a strictly temporary basis by

the Independent Alliance of MPs. Their remit will be to serve as caretakers, executing the democratic wishes of the Party as voted on by members. Candidates for Leader will be excluded from all oversight of operations around the running of the Leadership election. This oversight role will cease entirely once the CEC is elected.

5. The Inaugural CEC

- i. The Party's CEC shall be elected no later than 31st March 2026 and shall serve for a period of no more 21 months. Thereafter, elections will be held in advance of our national conference and the CEC shall serve for a period determined by the constitution.
- i.i. The principles underlying this election shall be fairness and transparency, with strong measures preventing any conflicts of interest.
- ii. The Party's CEC shall be responsible for running the party, overseeing its staffing, guiding its operations, driving its strategy within the parameters set by the National Conference, and determining its tactics.
- iii. This CEC shall consist initially of 16 ordinary members, representationally balanced in terms of gender, elected by the whole membership, the Leader, and 4 public office holder representatives, 2 of whom shall be Members of Parliament, and 2 of whom shall be local or regional public office holders.
- iv. There shall be additional reserved seats for organised sections (no more than five) and devolved nation representatives (one for each of Scotland and Wales) when these structures have been properly established.
- v. The CEC shall elect National Officers including Chair, Deputy Chair, Secretary, Treasurer, Political Officer, and Spokesperson, who shall alongside the Leader make up the Officers' Group.

- vi. The Officers' Group shall oversee the day-to-day running of the Party between CEC meetings, with the senior staff attending and reporting directly to it, as well as being answerable to the wider CEC.
- vii. Neither the Chair nor the Deputy Chair shall be Members of Parliament.
- viii. In the Party's first year, the CEC shall establish two working groups, open to all CEC members, one aimed at thoroughly establishing all the Party's structures, especially its regional structures, and the other at finalising all its core documents, subject to the outcomes of any consultations agreed within the Constitution.
- ix. Regularity of meetings and the establishment of other groups, working groups, or subcommittees shall all be matters at the discretion of the CEC.
- x. CEC membership is structured to encourage maximum power for grassroots members, providing separation of power and clear accountability, and ensuring the Party is not run from Westminster. Consequently, any Party member who is pursuing election to national public office, or Party selection for candidacy for said office, should regard it as unsuitable to seek election to the CEC as an ordinary member. Ordinary CEC members shall be barred from standing in such selections and from holding national public office on behalf of the Party.

6. Staffing and General Secretary:

- i. In the immediate term, and on a strictly temporary basis, a small team of staff will be recruited to support the Independent Alliance during their temporary stewardship. Candidates for Leader will not be part of this oversight. The elections will be run in an honest and transparent manner, with strict safeguards against nepotism. To this end, the elections will be run by an independent and professional third party.
- ii. This team will also manage organisational tasks related to the election of the Leader and the Central Executive Council, ensuring that processes are clear, fair, and inclusive. Furthermore, they will work in a transparent manner to facilitate the election and development of the Executive Leadership team (CEC

and Leader). This team must be strictly neutral, and must not be candidates or actively support any candidates in these elections In addition, the team will begin implementing all requirements set out in the founding documents, ensuring compliance and supporting the Party's long-term vision.

- iii. The CEC will appoint a General Secretary who in turn will oversee the development of senior roles and subsequent recruitment of several key staff; Director of Finance and Legals, Director of Organising, Director of Strategy, Director Communications. The General Secretary in conjunction with senior staff will devise a plan to be presented to the CEC containing different options for the future staffing structure; HQ staffing; regional staffing; and reporting mechanisms, with recommendations and a range of options.
- iv. Senior staff will attend and be answerable to the wider CEC this attendance will be in a non-voting capacity.

Employment rights and good practice will be respected, enshrined in all policies and with strong policies guarding against nepotism and conflicts of interest.

7. Elections 2026

- i. For the unique case of the 2026 Local Government elections, Your Party will seek to support all Independent socialist candidates of good standing where there is evidence of candidates being engaged in community campaigning and having the support of their local communities or trades unions branches.
- li. Your Party endorsements in the Holyrood and Senedd national elections will be agreed democratically by members in the relevant nation, including through an online all-member conference if necessary, supported by the interim Party leadership team as needed.
- iii. For the unique case of the 2026 local elections **only**, in the absence of properly established national branch and regional party infrastructure, the Independent Alliance shall facilitate democratic selections of candidates by local members in their

area, under OMOV. After this, due diligence shall be undertaken, conforming to rules against misuse for political purposes laid down under the standing orders, and a full candidate list shall be submitted to the Electoral Commission by the IA. Your Party will agree not to support any candidate where there is any unresolved local conflict.

iv. This is a unique process to be adopted due to time constraints and in the absence of agreed branch structures. This process shall apply for 2026 only and will not be repeated thereafter.

8. Party Affiliates

- i. A comprehensive consultation exercise and work plan for prospective Party Affiliates will take place as part of the party's opening 12-month strategic plan.
- ii. Affiliates encompass organisations such as trades unions, tenants unions/associations, campaign groups, etc. This list is not exhaustive.

9. Organised Sections

- i. Development of a membership-led body of work for Organised Sections will take place as part of the party's opening 12-month strategic plan to determine the best way for these to be organised within the party.
- ii. Organised sections encompass social groups such as the LGBTQ+ community, the disabled community, minority ethnic communities, women, young people, etc. This list is not exhaustive.

1. Introduction and Vision - 私たちは何に向かって取り組むのか

Your Party は、統一的(ユニタリー)大衆政党として、社会主義の伝統に深く根ざし、労働者運動と不可分の存在となる。左派のこうした組織が英国でかつて構築されたことがない事実、一般に大衆的政治形態が衰退していること、そして労働者階級と左派の漸進的な切断を踏まえると、この課題の大きさは党も認識している。それでも、党はこの取り組みが不可欠だと確信する。党が自らを「大衆的」とみなすのは、単に会員数や左派を結集・指導する能力だけではなく、党の綱領の背後に社会的多数派を形成することへ執拗に集中する点にこそある。

この**多数派志向**は、**英国社会の急進的変革**を(圧倒的多数の利益のために)可能にする条件を育むことを目的とする。

党は、インディペンデンツ運動の成功の上に築かれた。これは、労働党が労働者階級を見捨てたことと、ジェノサイドへの共犯とを等しく忌避する新しい選挙連合に支えられている。既成政党は有権者を無視し、とりわけ労働党は自らの支持基盤を執拗に攻撃し続け、その反動は極右台頭の燃料となっている。

Your Party はこれとは**異なるやり方**をとる。地域社会で組織化し、労働者運動の拡大と社会運動の強化によって力を築きつつ、地方・地域・国政の各レベルで選挙に挑み勝利することも目指す。

民主主義・包摂・透明性は、Your Party が実践し主張するすべての中心に据えられる。互いを貶めるのではなく、集合的な力を築くことに焦点を当てる。

2. 戦略目標(初年度)

私たちは**統一政党組織**の確立へ向かっている。**初年度の最上位目標は「構築」 **である:**組織構造・会員・オーガナイゼーション**を築く。これには次が含まれる。

a. 会員の拡大(Building memberships)

労働者階級のあらゆる領域、とりわけ労働党に見捨てられ、**極右が地歩を固めつつ**ある地域にまで、組織的成長を広げる。

b. 構造の構築(Building structures)

2025 年大会の決定を実装し、内部選挙の実施を含む組織構造の構築を促進する。これは、事務総長(General Secretary)と少数のサポートスタッフから成る小規模チームを必要とし、民主的構造を整備し、会員の支部設立を支援し、諸国(スコットランド/ウェールズ)とセクションの自律的組織化を後押しする。

c. オーガナイゼーションの構築(Building organisation)

地域社会と職場に党を根付かせる。コミュニティ・オーガナイザーと労組活動家が、 指導部および CEC が定める組織戦略に沿って、すべての取り組みで主導的役割を 果たす。

あわせて、選挙での民主的争点化にも向き合い、外へ打って出る。

d. 政治的リーダーシップ (Political leadership)

社会主義・反帝国主義の中核原則にしっかり根差しつつ、綱領のための社会的多数派形成に向け、明確で断固とした政治的指導を提供する。

i. 地域・職場での大衆的組織化と並行して、法的・選挙上の責務を果たし、2026 年の地方選挙で党方針に沿う候補者数を最大化する(スコットランドとウェールズの取り扱いは別途定める)。党は高度にプロフェッショナルであり、常に会員参加を最大化できる運営を行う。

本ペーパーは、政治宣言・憲章・議事規則に沿う、Your Party の実務的な組織提案を含む。

3. 党首と中央執行委員会(CEC)の選挙

党首と CEC の選挙は 2026 年 1 月に開始する(創立大会後、実務上最も早い開始時期)。投票は、信頼できる独立の第三者企業により運営される。選挙は 2026 年 3 月 31 日までに完了し、その時点で新リーダーシップチームが直ちに党運営を引き継ぐ。

4. 指導体制(Leadership)

- i. 初代党首は全党員投票(0M0V)で選出され、最長 21 か月の任期とする。その後は 全国大会に先立って選挙を行い、最終憲章が定める期間を任期とする。
- ii. 党首は CEC の議長・副議長とともに指導チームを構成し、党の立ち上げ期に政治的・戦略的指導を提供し、事務総長の業務を監督する。
- iii. 2 年目、CEC は将来の指導体制の選択肢を検討するレビューを開始し、提言と複数の構造案を提示する。指導の継続性を確保するため、このレビューは 0MOV の民主的投票に付し、2027 年末の全国大会前に実施される選挙に先立って決定し、結果を憲章に反映する。
- iv. 創立大会から初代 CEC 選出までの短期間は、党は独立系議員同盟 (Independent Alliance of MPs)が厳格に暫定的に管財役(ステュワード)として監督する。彼らの任務は、党員が投票で示した民主的意思を執行すること。党首候補者は、党首選運営に関わる業務の監督から除外される。CEC が選出され次第、この監督役割は完全に終了する。

5. 初代 CEC(The Inaugural CEC)

- i. 党の CEC は **2026 年 3 月 31 日までに選出**され、**最長 21 か月**の任期とする。その後は**全国大会に先立って選挙**を行い、任期は**憲章**で定める。
- i.i. この選挙の根本原則は公正と透明性であり、利益相反の防止を強固に図る。
- ii. CEC は、党運営・職員監督・活動指針・全国大会の枠内での戦略推進・戦術決定に 責任を負う。
- iii. 当初の CEC の構成は、通常委員 16 名(性別バランス考慮、全党員選挙)+党首+公職代表 4 名(国会議員 2 名、地方/地域公職者 2 名)とする。
- iv. 組織的部門(最大 5 席) および**分権諸国(スコットランド/ウェールズ)代表**(各 1 名)については、こ**れらの構造が整備された時点で**追加の**留保議席**を設ける。
- v. CEC は**全国役員(議長・副議長・書記・会計・政治担当・報道担当)**を選出し、 **党首とともに役員団(Officers' Group)**を構成する。
- vi. 役員団は CEC 会合間の日常運営を監督し、上級職員が出席・直接報告する。上級職員は CEC 全体にも説明責任を負う。
- vii. 議長・副議長は国会議員であってはならない。
- viii. 初年度、CEC は全 CEC メンバーに開かれた 2 つの作業部会を設置する。
 - 1) 党の全構造(特に**地域構造**)を本格整備する部会
 - 2) **中核文書の最終化**を担う部会(憲章で合意された協議の結果に従う)
- ix. 会合頻度やその他の委員会・作業部会・分科会の設置は、CEC の裁量とする。
- x. CEC の構成は草の根会員の権限最大化、権力分立、明確な説明責任を確保し、党がウェストミンスター主導で運営されないよう設計されている。したがって、国政の公職選挙への立候補を追求している党員、またはその公職候補者選定を求める党員は、通常委員として CEC に立候補すべきではない。通常委員は、そのような選定に立候補すること、また党を代表して国政の公職に就くことを禁じられる。

6. 職員体制と事務総長(Staffing and General Secretary)

- i. 直ちに、かつ厳格に暫定的な措置として、少人数の職員チームを採用し、独立系議員同盟による暫定監督を支援する。党首候補者はこの監督に関与しない。選挙は公正かつ透明に運営し、縁故主義対策を厳格に講じる。そのため、選挙は独立の専門第三者によって実施される。
- ii. このチームは、党首と CEC の選挙関連の組織業務を管理し、明確・公正・包摂的 なプロセスを確保する。さらに、役員リーダーシップ (CEC と党首) の選挙・整備を透明に促進する。このチームは厳格に中立であり、候補にならず・特定候補を支援しない。加えて、創設文書の要件を実装し始め、コンプライアンスを確保し、党の長期 ビジョンを支える。
- iii. CEC は**事務総長(General Secretary)**を任命し、事務総長は上級職の整備と主要スタッフの採用を監督する:

財務・法務ディレクター、オーガナイジング・ディレクター、戦略ディレクター、コミュニケーション・ディレクター。

事務総長は上級職員と連携して、将来の職員体制(本部/地域/レポーティング機構)に関する複数案と提言をまとめ、CECに提出する。

iv. 上級職員は CEC 全体に出席し説明責任を負う(議決権なし)。雇用権と適正手続を尊重し、縁故主義と利益相反を防ぐ強固な方針をすべての規程に明記する。

7. 2026 年選挙(Elections 2026)

- i. 2026 年の地方選挙に限る特例として、Your Party は、地域でのキャンペーンに 従事し、地域社会や労組支部の支持を得ている善良な独立系社会主義候補を支援 することを目指す。
- ii. ホリルード(スコットランド議会)およびセネッド(ウェールズ議会)の国政選挙における Your Party の支持(エンドースメント)は、必要に応じてオンラインの全党員会議を含め、当該国の党員が民主的に決定する。必要に応じ暫定指導部が支援する。
- iii. 2026 年の地方選挙に限り、全国支部・地域党インフラが未整備の場合は、独立系議員同盟(IA)が、該当地域の党員による 0MOV で候補者の民主的選定を促進する。

その後、議事規則で定める政治的濫用防止規定に則ってデューデリジェンスを行い、候補者一覧をIAが選挙管理委員会に提出する。未解決の地域紛争がある候補を Your Party は支持しない。

iv. これは、時間的制約と合意済み支部構造の欠如に起因する 2026 年のみの特例であり、以後は繰り返さない。

8. 提携団体(Party Affiliates)

- i. 発足後 12 か月の戦略計画の一環として、提携団体制度に関する包括的協議と遂行計画を実施する。
- ii. 提携団体には、労働組合、借家人組合/協会、各種キャンペーングループなどを含む(例示であり限定ではない)。

9. 組織的部門(Organised Sections)

- i. **発足後 12 か月の戦略計画**の一環として、**組織的部門**を党内でどう編成するのが 最適かを定めるため、**会員主導の検討と設計**を進める。
- ii. 組織的部門には、LGBTQ+コミュニティ、障害者コミュニティ、少数民族コミュニティ、女性、若者などの社会的グループを含む(例示であり限定ではない)。
